Dear Prime Minister Albanese,

Giving Voice to "...50,000 years of Aboriginal Care for Country..."

Thank you for the Australian Labor Party responses to our extreme bushfires campaign letters to Prime Minister's, including the one containing the above quote¹. You may recall, it stated:

"We believe your letter...disenfranchises 50,000 years of Aboriginal Care for Country, by calling Extreme Bushfires a 'Natural Disaster', when it is Federal Government policies that create and pay for them" (letter to PM, firestickestate.com Letters No. 628 and your response, No. 653). You responded: "I have forwarded your email...to our policy team for their review and consideration".

With the greatest respect, now that you are Prime Minister, 'please inform us if your policy team gave Voice to 'Aboriginal Care for Country', mitigating extreme bushfires? A book called "mass murder" and the cover ups, addresses this Voice in the context of extreme bushfires². The quote "mass murder" comes from your former leader, now Ambassador to the USA³. Other mentions of your Labor Party colleagues are: Australian Government Attorney General Mr Dreyfus⁴, you when you were the Australian Labor Party Opposition leader⁵, and the government more generally⁶.

The USA Maui fire in August suggests failures remarkably similar to Australia's 2009 Black Saturday Fires, when your former leader stated: "...our Aboriginal brothers and sisters have occupied this continent for 40,000 years, there is great wisdom to be learned'⁷⁷. It is clear 'Aboriginal Care for Country...is great wisdom', but your inaction disrespects that wisdom, a vital basis of Voice.
